Ticket 1885 - No mention of SCE.

Issue

Latest Doc build (39838) that accompanies app 39895 has no mention of the SCE. Core 2.1.0.3 with App 39895 is primarily introducing the Cisco SCE (previously

PCube) into the App. There are now several more TZZ packages for the SCE that need to be installed. These need to be included in the Customer Installation Instructions, as well as an overview of the SCE & what its purpose is.

Resolution:

Chapter 4 of the *Cisco Broadband Policy Manager Software Installation and Configuration Guide* has been rewritten. See the section, Documentation Changes, below.

Ticket 1888 - SCE documentation in wrong manual.

Issue

The Service Control Engine chapter is currently in the Admission Control Manager Guide, but use of the SCE is not related to ACM, it's related to SM/NM. The chapter should be moved to the IP Service Manager Guide.
